### **<u>Chairperson's Message</u>**

"I want to take a moment to look back on the past year and highlight RLCC's achievements in empowering women. Despite challenges, we remained focused on our goals in 2021-2022.

We broke sales records through successful participation in 32 exhibitions, showcasing up-cycled and handmade products crafted by 250 home-based workers.

Our Ra'ana Liaquat Public School retained 318 students and welcomed 169 new students.

The refurbished RLCC Community Health Clinic provided affordable healthcare services to over 10,000 beneficiaries. We also collaborated with the LRBT eye clinic and a satellite clinic to extend our reach and offer vaccinations and paediatric care.

Partnering with the Robin Hood Army, we supported 213 families with rations.

Our commitment to sustainable waste management resulted in a community clean-up drive involving 40 staff members.

Throughout this period, we remained dedicated to Begum Raana Liaquat Ali Khan's vision and prioritised accountability and transparency. The Annual Report for 2021-22, showcasing our impact, is available for your review.

## **Our Story**

When India and Pakistan got partitioned, hundreds of thousands of families migrated, leaving behind all their worldly possessions. These included landed gentry, professionals, artisans, all with no prospects of livelihood in a new land. It was the women who were impacted the most in this incredibly bloody partition. Robbed of their lives and livelihoods, their prospects were understandably bleak. Cognizant of the plight of immigrant women, Pakistan's first lady Begum Raana Liaquat started a craftsmen colony which aimed at becoming a self-sustaining community providing artisans the opportunity to use their crafts and provide their families with education and healthcare.

Raana Liaquat Craftsmen's Colony, founded by Begum Ra'ana Liaquat Ali Khan in 1947, inaugurated on 25th August 1954, is a rights-based nonprofit organization that caters to the holistic needs of over 20,000 beneficiaries. RLCC has evolved as a forward looking, conscientious organization registered with Voluntary Social Welfare, certified by PCP, and recognized as an NPO under the Income tax Ordinance, 2001.

The women-centric programs at RLCC are strategized in consideration of community needs, government priorities, and the targets identified by United Nations' Sustainable Development Goals (SDG's) with sector focus on education, health, vocational training, community outreach, and livelihoods. The APWA RLCC Raana Liaguat Public School, built-in 1954 has been promoting access to quality education and opportunities for learning. The organization continues to strive towards its mission to facilitate improvement in the social and economic well-being of low-income communities.




### **Our Success**

Surviving as an organization post-Covid-19 was a daunting challenge for RLCC, and it was crucial to bring viability back to the community. Many male breadwinners among the artisan's families lost their jobs due to the economic crisis. RLCC stepped in and offered them opportunities for earning through becoming delivery riders. One such story is that of Rozi and her husband Robert, who have been associated with RLCC for the past 10 years.

"Covid-19 was an extremely difficult phase for us. I lost my job, where I earned overtime and it was a real financial loss for us. RLCC provided me with an alternative to it through offering delivery jobs. It really supported me and my family. I used to deliver their orders to their respective customers and earned enough to sustain me and my family in difficult times. At the same time Rozi was busy working as an artisan and doing her best to support us " Robert




Annual result of SSC

#### INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF APWA RANA LIAQAT CRAFTMAN'S COLONY WELFARE PROJECT

#### Opinion

We have audited the financial statements of APWA RANA LIAQAT CRAFTMAN'S COLONY WELFARE PROJECT (the Welfare Project), which comprise the statement of financial position as at June 30, 2022, and income and expenditure account, the statement of changes in funds, the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Welfare Project as at June 30, 2022 and its financial performance and its cash flows for the year then ended in accordance with accounting and reporting standards as applicable in Pakistan.

#### **Basis for Opinion**

We conducted our audit in accordance with International Standards on Auditing (ISAs) as applicable in Pakistan. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Welfare Project in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants as adopted by the Institute of Chartered Accountants of Pakistan (the Code), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Responsibilities of the management and the Board of Governors for the Financial Statements

The Management of the Welfare Project is responsible for the preparation and fair presentation of the financial statements in accordance with the approved accounting and reporting standards as applicable in Pakistan and for such internal control as the Board of Governors determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Management is responsible for assessing the Welfare Project's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Welfare Project or to cease operations, or has no realistic alternative but to do so.

The Board of Governors is responsible for overseeing the Welfare Project's financial reporting process.

As part of an audit in accordance with ISAs as applicable in Pakistan, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to
  fraud or error, design and perform audit procedures responsive to those risks, and obtain audit
  evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting
  a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may
  involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal
  control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Welfare Project's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Welfare Project's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Welfare Prroject to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.
