Reflecting on the past year, I'm thrilled to share RLCC's progress in empowering women during 2023-2024. Despite facing challenges, we remained steadfast in our mission.

Our participation in 32 exhibitions led to record-breaking sales, showcasing upcycled products by 250 home-based workers. Additionally, our school saw 318 students retained and 169 new students welcomed, underlining our commitment to education.

The RLCC Community Health Clinic provided vital healthcare to over 10,000 beneficiaries, with extended services including vaccinations and paediatric care through collaborations with other clinics. We also supported 213 families with rations in partnership with the Robin Hood Army.

Our dedication to sustainable waste management was evident in a community clean-up drive involving 40 staff members.

The Annual Report for 2023-2024, highlighting our impact, is available for your review.

I extend heartfelt thanks for your continued support, which enables us to transform the lives of the women we serve.

Our Story

When India and Pakistan got partitioned, hundreds of thousands of families migrated, leaving behind all their worldly possessions. These included landed gentry, professionals, artisans, all with no prospects of livelihood in a new land. It was the women who were impacted the most in this incredibly bloody partition. Robbed of their lives and livelihoods, their prospects were understandably bleak. Cognizant of the plight of immigrant women, Pakistan's first lady Begum Raana Liaquat started a craftsmen colony which aimed at becoming a self-sustaining community providing artisans the opportunity to use their crafts and provide their families with education and healthcare.

Raana Liaquat Craftsmen's Colony, founded by Begum Ra'ana Liaquat Ali Khan in 1947, inaugurated on 25th August 1954, is a rights based non-profit organization that caters to the holistic needs of over 20,000 beneficiaries. RLCC has evolved as a forward looking, conscientious organization registered with Voluntary Social Welfare, certified by PCP and recognized as an NPO under the Income tax Ordinance, 2001.

The women-centric programs at RLCC are strategized in consideration of community needs, government priorities, and the targets identified by United Nations' Sustainable Development Goals (SDG's) with sector focus on education, health, vocational training, community outreach, and livelihoods. The APWA RLCC Raana Liaquat Public School, built-in 1954 has been promoting access to quality education and opportunities for learning. The organization continues to strive towards its mission to facilitate improvement in the social and economic well-being of low-income communities.

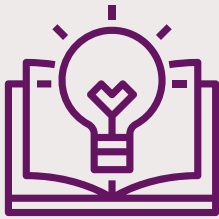

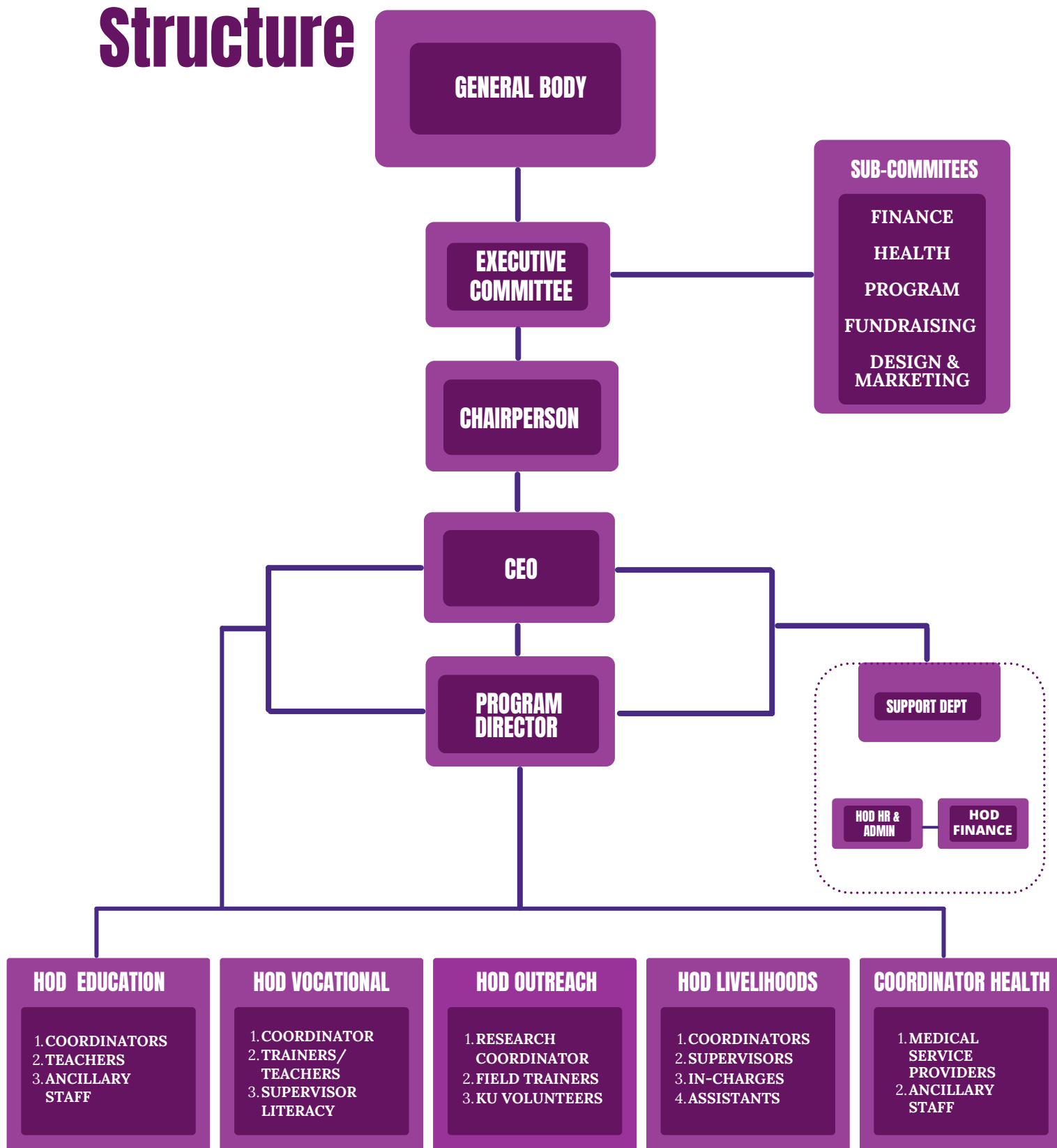
Our Success

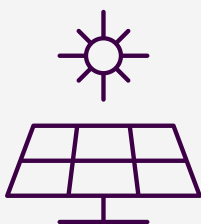
Increasing beneficiaries

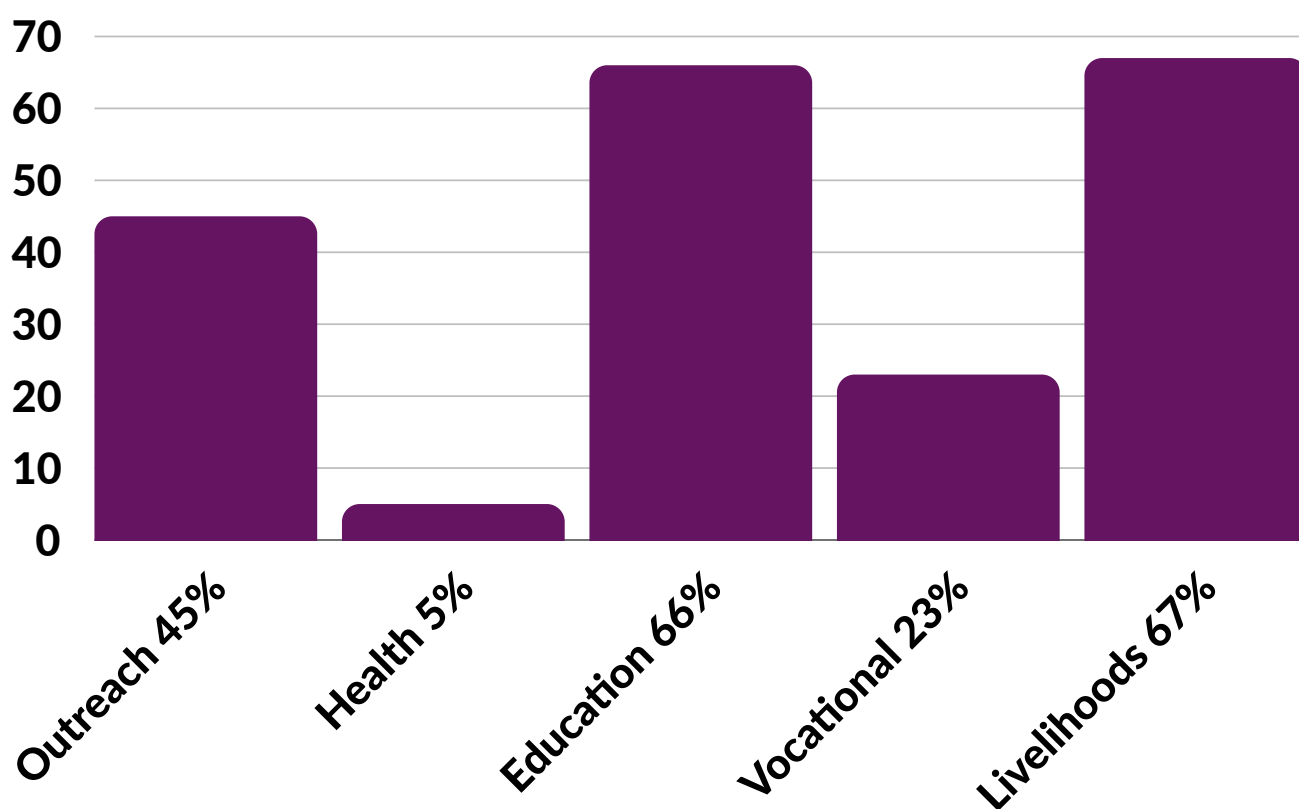

Health



RLCC has developed a comprehensive health program, focused primarily on two initiatives: the Community Health Clinic and the Promotive and Preventive Health Program



Access to Affordable and Quality Healthcare

Quality health care education & treatment provided to **10,188** women and young people (**45% beneficiaries recovered with follow-up visits**)



Free Medical Camps

Free medical camps facilitated around **2,165** beneficiaries. Distributed donated medicines valued at approximately Rs. **50,000**. increased beneficiaries in **LRBT** and **COL** clinics after medical camps.



School Health Program

The health program catered to around **218** students. referred **27** students to child specialist for further treatment.



Vocational



The Vocational Training Program operates in synergy with other departments and programs at RLCC. Its primary goal is to impart skills to women, enhancing their capabilities and providing them with employment opportunities in the market. This, in turn, enables them to better access education and health services for the benefit of their families.



Increased Access to Vocational Trainings

472 women provided quality vocational training and 166 students passed out from courses out of which 39 students are currently earning a livelihood after completing the vocational training program, 23% job placement.



Establishing Linkages

A trip was arranged for students at YTM Around 30 students from the cutting and sewing class visited and 5 students got job opportunity.

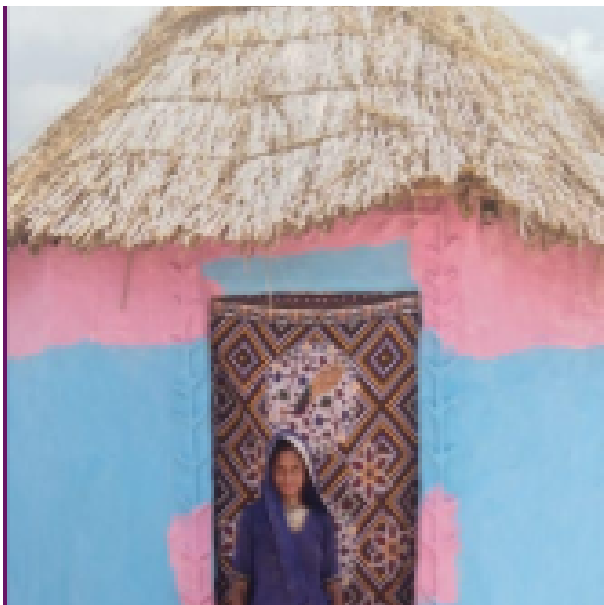

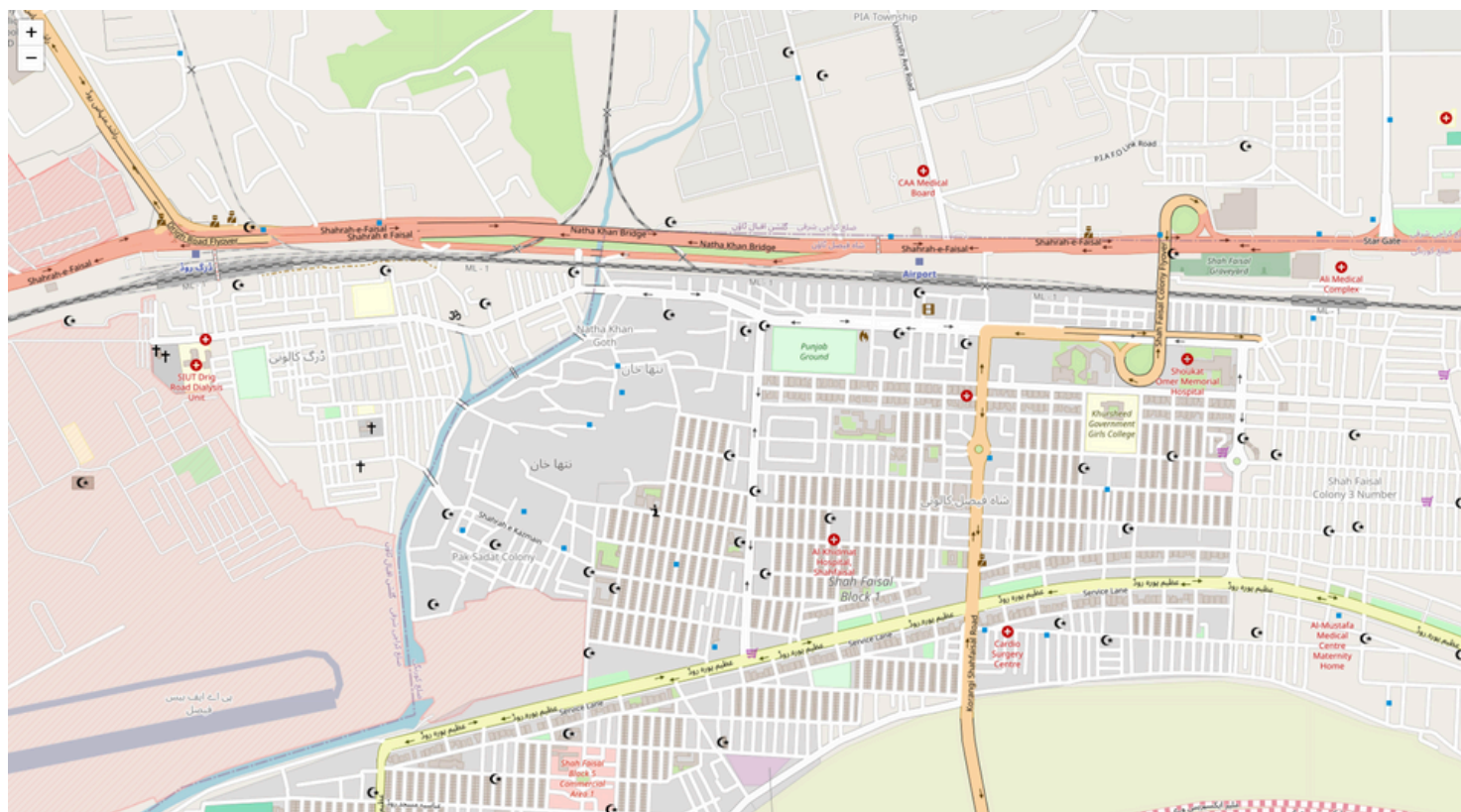

Students took part in a number of extra-curricular activities such as workshops on good citizenship and capacity building.



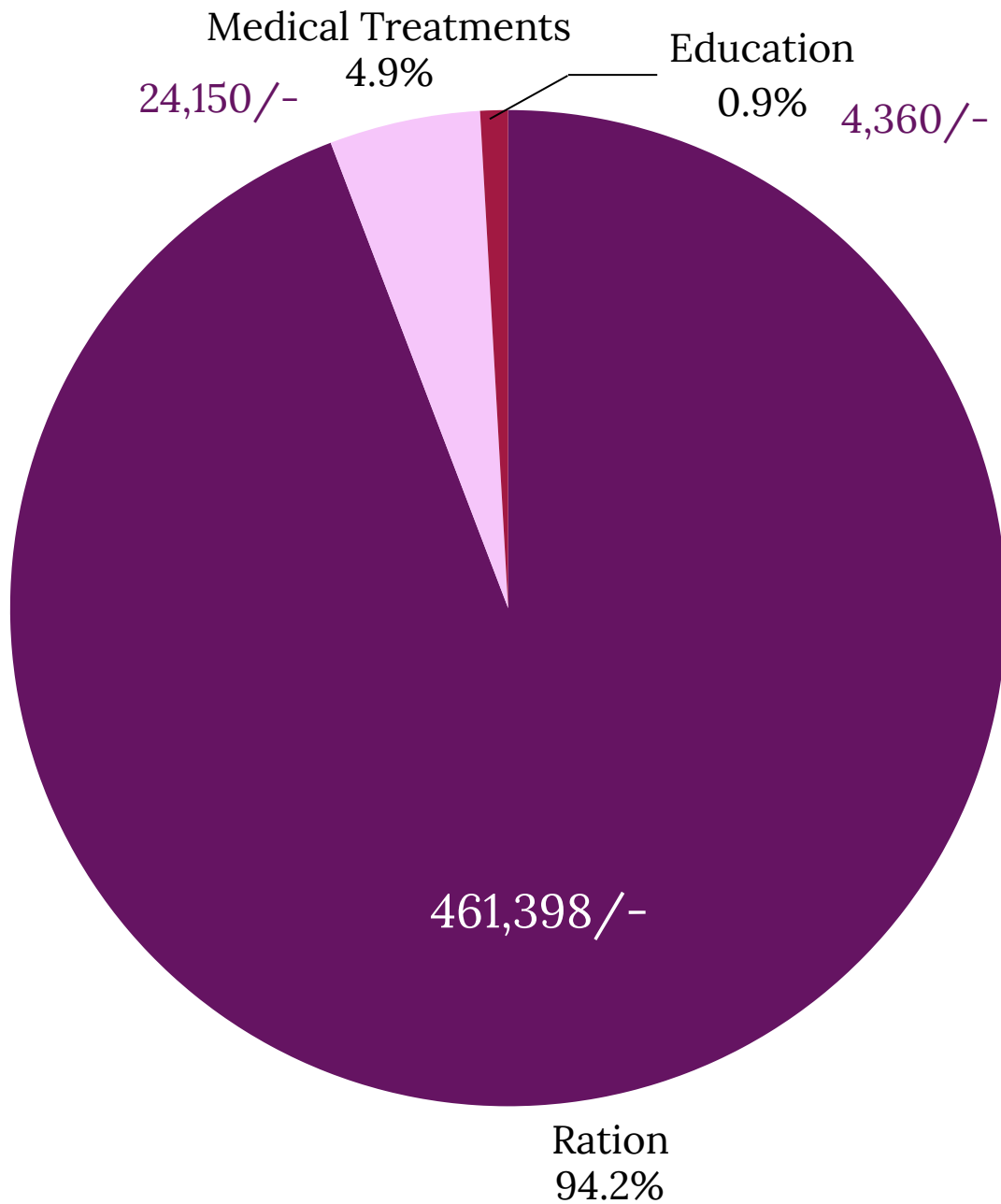
Future Plans

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF APWA RANA LIAQAT CRAFTMAN'S COLONY WELFARE PROJECT

Opinion

We have audited the financial statements of APWA RANA LIAQAT CRAFTMAN'S COLONY WELFARE PROJECT (the Welfare Project), which comprise the statement of financial position as at June 30, 2023, and the statement of income and expenditure, the statement of changes in funds, the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Welfare Project as at June 30, 2023 and its financial performance and its cash flows for the year then ended in accordance with accounting and reporting standards as applicable in Pakistan.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs) as applicable in Pakistan. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Welfare Project in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants as adopted by the Institute of Chartered Accountants of Pakistan (the Code), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of the management and the Managing Committee for the Financial Statements

The Management of the Welfare Project is responsible for the preparation and fair presentation of the financial statements in accordance with the approved accounting and reporting standards as applicable in Pakistan and for such internal control as the Board of Governors determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Management is responsible for assessing the Welfare Project's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Welfare Project or to cease operations, or has no realistic alternative but to do so.

The Managing Committee is responsible for overseeing the Welfare Project's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs as applicable in Pakistan will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISAs as applicable in Pakistan, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Welfare Project's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Welfare Project's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Welfare Project to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.



We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
