I am honored to share RLCC's impactful achievements for the year 2024–2025, reflecting our unwavering commitment to empowering women and strengthening communities, even amid challenging circumstances.

Throughout the year, RLCC demonstrated remarkable resilience and growth. Our participation in 24 exhibitions resulted in record-breaking sales, showcasing an inspiring range of upcycled products crafted by 217 skilled home-based artisans. This achievement highlights not only the exceptional talent within our communities but also the increasing recognition of sustainable and ethical craftsmanship.

Our vocational training initiatives continued to create meaningful change by equipping over 489 students with market-relevant skills aligned with local economic needs. These programs enabled participants to enhance their employability, generate income, and build sustainable livelihoods for themselves and their families.

In education, our school made significant progress by retaining 695 students. This milestone reflects our strong commitment to providing accessible, quality education that nurtures confidence, knowledge, and long-term empowerment.

Healthcare remained a vital pillar of our work. Through our Community Health Clinic, we delivered essential medical services to more than 11,500 individuals, including vaccinations and paediatric care, ensuring improved access to quality healthcare for underserved populations.

The Outreach Department directly engaged 14,449 individuals through awareness sessions, campaigns, and community initiatives, empowering them with knowledge and resources for improved health, education, and livelihood opportunities.

The 2024–2025 Annual Report, detailing these achievements and our wider impact, is presented for your review. Your continued support has been fundamental to these accomplishments, enabling us to drive sustainable, meaningful change for the women and communities we serve.

Our Story

When India and Pakistan got partitioned, hundreds of thousands of families migrated, leaving behind all their worldly possessions. These included landed gentry, professionals, artisans, all with no prospects of livelihood in a new land. It was the women who were impacted the most in this incredibly bloody partition. Robbed of their lives and livelihoods, their prospects were understandably bleak. Cognizant of the plight of immigrant women, Pakistan's first lady Begum Raana Liaquat started a craftsmen colony which aimed at becoming a self-sustaining community providing artisans the opportunity to use their crafts and provide their families with education and healthcare.

Raana Liaquat Craftsmen's Colony, founded by Begum Ra'ana Liaquat Ali Khan in 1947, inaugurated on 25th August 1954, is a rights based non-profit organization that caters to the holistic needs of over 20,000 beneficiaries. RLCC has evolved as a forward looking, conscientious organization registered with Voluntary Social Welfare, certified by PCP and recognized as an NPO under the Income tax Ordinance, 2001.

The women-centric programs at RLCC are strategized in consideration of community needs, government priorities, and the targets identified by United Nations' Sustainable Development Goals (SDG's) with sector focus on education, health, vocational training, community outreach, and livelihoods. The APWA RLCC Raana Liaquat Public School, built-in 1954 has been promoting access to quality education and opportunities for learning. The organization continues to strive towards its mission to facilitate improvement in the social and economic well-being of low-income communities.





Success Story

Hailing from Natha Khan Goth, Shah Faisal Colony, Haleema Bibi enrolled in RLCC's Beautician Program in June 2024 with a clear determination to support her family and build a stable livelihood. Over the course of one year, she remained hardworking, committed, and eager to master new skills in beauty and personal care.

Despite limited resources, her family supported her ambitions by preparing a small room in their home to serve as a parlor space. Initially, they were only able to install a wall shelf for her beauty products.

Recognizing her dedication and potential, RLCC provided PKR 51,000 on 18th June 2025 to help her purchase essential items needed to establish a functional beauty parlor. With this support, she successfully set up her basic home-based parlor.

Today, she receives 3–6 clients per week, offering services such as threading, facials, mehndi, and makeup. Her monthly income now reaches approximately PKR 25,000, which she uses to contribute to household needs and supports the medical expenses of her differently abled sister. As her work grows and becomes more stable, she plans to hire a helper from within the community demonstrating her aspiration not only to uplift herself but also to create opportunities for others.

Her journey reflects how skill-building, opportunity, and timely support can empower young women to build dignified, sustainable livelihoods.



Success Story

Faiza has been associated with RLCC as an artisan for the past sixteen years. Initially, she worked in the paper craft section, producing handmade products such as envelopes, paper trivets, paper jug coasters, and paper frames.

Four years ago, she decided to enhance her skills and learned handloom weaving under the guidance of the master trainer at RLCC. Since then, she has been producing high-quality products and earning a monthly income of up to PKR 40,000. Through consistent savings, Faiza was able to support her parents and also contribute to her wedding expenses eight months ago.

With the support of her family, particularly her father-in-law who helped her install a loom at home in March 2025, Faiza now operates her own small-scale loom setup. She continues to produce and sell woven products, ensuring a steady source of income and contributing to her household financially.

Faiza proudly shares that RLCC has empowered her to become self-reliant and confident, turning her from a trainee artisan into an independent craftswoman and entrepreneur.

INDEPENDENT AUDITOR'S REPORT TO THE MEMBERS OF APWA RANA LIAQUAT CRAFTMAN'S COLONY WELFARE PROJECT

Opinion

We have audited the financial statements of APWA RANA LIAQUAT CRAFTMAN'S COLONY WELFARE PROJECT (the Welfare Project), which comprise the statement of financial position as at June 30, 2025, and the statement of income and expenditure, the statement of changes in funds, the statement of cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Welfare Project as at June 30, 2025 and its financial performance and its cash flows for the year then ended in accordance with accounting and reporting standards as applicable in Pakistan.

Basis for Opinion

We conducted our audit in accordance with International Standards on Auditing (ISAs) as applicable in Pakistan. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Welfare Project in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants as adopted by the Institute of Chartered Accountants of Pakistan (the Code), and we have fulfilled our other ethical responsibilities in accordance with the Code. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of the management and the Managing Committee for the Financial Statements

The Management of the Welfare Project is responsible for the preparation and fair presentation of the financial statements in accordance with the approved accounting and reporting standards as applicable in Pakistan and for such internal control as the Board of Governors determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Management is responsible for assessing the Welfare Project's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Welfare Project or to cease operations, or has no realistic alternative but to do so.

The Managing Committee is responsible for overseeing the Welfare Project's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs as applicable in Pakistan will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISAs as applicable in Pakistan, we exercise professional judgment and maintain professional skepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Welfare Project's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.
- Conclude on the appropriateness of management's use of the going concern basis of accounting and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Welfare Project's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate to modify our opinion. Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Welfare Project to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.
